

It has been my great pleasure to serve as your board president this year. There has been much to celebrate, with many opportunities for participation, and increased transparency reflected in the work of this year's board.

CELEBRATIONS

Here for Good, the \$400,000 capital project to renovate our 1860 sanctuary building. Last year funds were raised; this year the work was done, and is nearly complete, with just \$10K in pledges to be fulfilled to complete the work. Paving the way for growth, we now have an accessible Chancel, a beautiful Gathering Room, new driveway, and many behind the scenes

improvements. We now sunset this campaign, and turn to our Buildings & Grounds Committee to complete the remaining tasks as funds are received.

Growth. We have welcomed dozens of newcomers this year, several choosing to officially join us in membership. This year's annual campaign celebrates 10% growth in families making a financial commitment to our congregation, and 10% growth in dollars committed. We celebrate full staffing as of last fall!

Fundraising. With our renovated sanctuary inviting new uses of the space, we successfully launched a new music series, welcoming the wider community. We are meeting our ambitious fundraising budget with continuation of our traditional events and activities, including Clam Fest, Holiday Fair, Gala, Hannaford Cards, Scrips Gift Cards, Maine Farm Supper, and an assortment of creative smaller opportunities.

Collaboration. The board celebrates our congregational shared ministry. Examples include collaborating more closely with Reverend Jennifer on our programs of social justice and all-ages religious education, developing the mission statement visual EXPLORE ENGAGE EMBRACE now being implemented in our 'branding' to the wider community, and beginning development of a strategic plan.

OPPORTUNITIES

New Yarmouth Venue. Our renovated sanctuary and gathering room presents new opportunities to be a venue for weddings, performances, meetings, and private gatherings. The opportunity for YOU is to participate on one of the new teams being created to research, market, and support these opportunities. Performances are already being scheduled for next fall and spring – plan to come!

TRANSPARENCY

The Financial Times of First *U* is now published monthly to highlight current topics of celebration, opportunity, and transparency. This is a collaborative effort of Stewardship, Member Services, and our Program Assistant, Gwen Matthews.

Financial processes and controls. Much progress has been made, but there is still work to be done, and anyone with financial interest or experience is welcome to join in this effort!

Financial Commitments. The Here for Good project has been performing within budget, with about \$10,000 yet to be paid in 2017 commitments. Annual Campaign commitments for the current church year: about \$12,000 yet to be paid, and due before June 30. Annual Campaign commitments for the coming church year: we await about \$8,000 in commitments from about a dozen active families before July 1. Timely payments and commitments are deeply appreciated, and essential to maintain positive cash flow. Of course, additional gifts are always welcome!

Fundraising

Our fundraising involves FOOD and FUN and nearly everyone in our church community in one or more of our events, many of which welcome the wider community to discover First U. Annual events include the Clam Fest, Holiday Fair, Heart-in-Hand Gala, Maine Farm Supper, and the series of Gather Dinners.

The additional major fundraiser is the Hannaford Card Program; many families use these cards so that Hannaford donates 5% of the families' Hannaford purchases throughout the year. A new offering is the 'Scrips' Gift/Cash Card Program, which create 5% to 18% donations by the companies to First U. If you have not yet participated in these lucrative programs, please start now!

Financial Report

We continue to improve the financial management, process, and reporting using the new software systems. With our able Office Assistant Gail Mills on board, all is moving along quite smoothly, and we are able to track income and expenses, and manage discrepancies on a timely basis. We expect to end this fiscal year on June 30 very close to break-even, assuming financial commitments are paid in a timely manner. We closed the prior fiscal year (FY16) with a tiny surplus of \$697. What follows are current year-to-date reports as of April 30, and the proposed operations budget for the next fiscal year which begins July 1.

The job of the Buildings and Grounds Committee is to manage our historic church and parsonage facilities and the surrounding grounds.


BUILDING & GOUNDS COMMITTEE 2016-2017

This year, Russ DuPree is a very welcome addition to the church staff as our Sexton. His efforts keep things noticeably neat and clean inside the church and the steps and walks clear of snow outside. For the paperwork task of bill paying, B&G gratefully receives support from our Office Assistant, Gail Mills. Sarah Witte and Joanna Landsman continued to lead the design and care of the lovely planting around our church grounds.

Buildings and Grounds handles on-going maintenance of our facilities including:


- Management of test/inspection/maintenance of church building systems: elevator, fire sprinkler, fire alarm, emergency lighting, fire extinguishers, smoke detectors, and three heating systems.
- Delivery of church trash and recyclables to the transfer station as well as delivery of returnables to the redemption center.
- Management of our grounds including snow removal, lawn mowing, and raking.
- Parsonage routine maintenance of furnace, furnace filter, and annual replacement of smoke detector batteries.
- Seasonal changes to heating, storm windows, and outside faucets.
- Technology support for our office equipment (3
- computers and copier) and performing weekly computer backups.
- Supporting use of our projector and the sounds systems in the Sanctuary and Gathering Room.



- Major work was completed under the Here for Good capital campaign including: redesign of the chancel in the Sanctuary; new concrete floor and sound absorption in the Gathering Room; resurfacing of the driveway; and purchase of 50 new stackable chairs (25 "old" chairs were donated to Furniture Friends).
- A donated baby grand piano replaced the upright piano in the Sanctuary.
- The elevator was unfortunately out of service for several weeks while a replacement for a warped door was ordered and installed.
- Our magnolia tree was given a systemic treatment for an infestation of Magnolia Scale.

Here are the highlights of the MS year:

- The Turning Point Curriculum, developed by Gwen. We presented 6 Sunday morning conversations and Gwen and Rev. Jennifer used it as the basis of a Sunday worship service.
- Coffee Hour responsibilities were shared by all committees and small groups in the congregation. After some initial resistance, this system seems to be going smoothly.



- Gather Dinners continue. We currently have 4 per church year, October, January, March, and June. Join us on June 29 for the final Gather dinner of this church year!
- UU Heritage Tour in Boston had 20 adult participants and 7 children/youth.
- Greeter Program launch, including a greeter training.
- We initiated a *Buddy System* to meet and follow up with newcomers.
- One potluck *Newcomer Dinner* was co-hosted by Jane Cleaves and Nancy Read.
- New, redesigned *Name Tags* and clean up of old name tag area.
- The return of *Pi(e)* Sunday. After a break for the Bake Off of 2016, Pi(e) Sunday returned. We had many delicious pies and the coffee hour seemed like a happy success.
- Development of a new event: Our Spiritual Journeys. The event featured a luncheon, a facilitated discussion by Rev. Jennifer, and then a new member book signing ceremony. We had seven new adult members join us this year and there seems to be another group right behind them, and another wave behind them, just what we dreamed of!
- Member Recognition Sunday, on May 21, will bring attention to members, old and new.
- We created and distributed magnetic and postcard *Church Calendars* available at Ingathering.

MEMBER SERVICES COMMITTEE

Ideas going forward:

- Clarify the mission and charge to Member Services. So many events and ideas can fall under MS, it helps to have a clear area of responsibility.
- Continue to actively greet and reach out to newcomers. Member Services may want to
 look at an organizational change, with the possibility that some committee members focus
 on outreach and new members, while others focus on building the connections and
 endoskeleton, i.e. Re-Membering effort. A current and reliable directory is essential to the

HEALTHY CONGREGATION TEAM

This report contains two components: first, that a team is working toward healthy functioning among staff and members, and second, that another team of the church is working toward maintaining the health of those who use our church building.

HEALTHY CONGREGATION TEAM 2016-2017

Proactively, we consult with Reverend Jennifer to think through how to implement an agreed-on plan regarding healthy functioning of the congregation. For example, we have been thinking through how we can help church members covenant with one another. We think about the healthy emotional tone of the church and how we function together.

Covenanting is defining how we will worship and be together in beloved community. We meet monthly during the church year and respond immediately when a crisis arises. For example, we responded to a situation in which a staff member was threatened by someone who had attended but was not a member of the church. We respond if a member asks to meet with team members. We also ask to meet with a church attendee or member if someone alerts us about a disquieting situation.

At the Board retreat in October of 2016, as part of a discussion about our Safe Congregation Policy, a safety team was suggested and charged with making recommendations about how to keep all who use the building of the First Universalist Church safe from a variety of potential threats.

To that end, Jane Cleaves and Steve Thomas:

- First met with the Village Nursery School teachers and President of their Board in January 2017. Eventually, Gail Mills and Charlie Horstmann joined the committee.
- Steve and Jane attended a day-long workshop on active shooters conducted by the US Department of Homeland Security.

As a full team we have met three times and identified potential risks:

- a person with a mental illness appears to threaten or decompensate and frighten staff
- someone intends to take a child without proper authorization
- someone intends to do violence or cause physical harm
- there is a fire or medical emergency

At present, we are addressing access to the building when a small number of staff or Village Nursery School teachers and children are present.


