Discussion Agenda

1. The 95 Main Project (New Mainers in the Parsonage)

QUESTION: Who owns this project? Board, FIA, B&G? What will need to happen to make it work? What are the implications for selection of our next settled minister?

DISCUSSION:

None of the committees have the bandwidth for owning the project.

Pete Titcomb concerned with facilities mgmt. and project administration. B&G is not going to take on this project; still looking for new leadership in our own B&G. Property Manager. Rent might need to include professional services. Will have relationship with 3 or so tenants, either long term or short term.

DECISION: A project team of all partners (3 from First Univ, 3 from YCHI or St Barts) needs to be created. Ultimately we can envision a separate 501c3.

Opportunities: a chance to renew our mission in a new space.

Phase 1. Launch. First Univ. provides building.

Phase 2. Ongoing. First Univ. may provide conversation circles, community dinners, etc. Training for relationships with New Mainers.

Rent will include utilities. Asylum seeking and work permit pending eligible individuals would have GA of \$700 (or so) and then a job with good enough income to pay when GA runs out. Community acceptance: understanding reality. Rent IS being paid. Build FAQ or Q&A. Future minister: not likely to want to live there.

DECISION: We authorize an Ad Hoc team of the Board (aka the "95 Main") to proceed with this project.

2. Midyear Meeting

QUESTION: Were all of our committee goals affirmed, and were all the charges accepted? How would we evaluate the World Café format?

DISCUSSION of World Café Format: Cons: There was not enough time. We didn't have big sign-ups, and we didn't get great reports or notes. Spatial – a bit crowded.
